### **MEETING SUMMARY**

Advisory Committee Meeting Flood Control Zone District June 21, 2010 2:30 - 4:30 p.m.

## **Location**

Skagit Room, Skagit County Administrative Building, 1800 Continental Place, Mount Vernon, WA.

### **Meeting Purpose**

For the Flood Control Zone District (FCZD) Advisory Committee (AC) members to conduct normal business and:

- 1. CFHMP First Draft Review Guidelines
- 2. "Blueprint" Meeting Discussion
- 3. To determine next steps and Technical Committee assignments (if any)

### <u>Introduction</u>

Chairman Bob Boudinot opened the meeting by welcoming everyone to the meeting.

#### **Public Comment**

Carol Ehlers mentioned the *UGA Open Space Plan* has useful environmental information for the *Skagit River CFHMP*. The document, which received an award from the Governor, includes activities from Farmland Legacy, Seattle City Light, and the national parks. On another subject, Ehlers pointed out a story regarding a new culvert on Fidalgo Island. While the culvert opened up the creek for better flow during record rainfall, it allowed the yellow perch to be washed out. She explained how it is an example of balancing one need for another.

## Acceptance of April 19, 2010 AC Meeting Summary

Larry Kunzler moved to accept the meeting summary from April 19, 2010. Todd Carlson seconded the motion. Motion passed (13-0-0).

#### **Regular Report Outs**

**County Engineer**: Mark Carey and Ryan Ike, both from FEMA, gave a presentation to the Board of Skagit County Commissioners regarding the Flood Insurance Map release scheduled for June 30. Pursuant to the Board's request, the public comment period has been extended from 30 to 90 days. FEMA also presented a technical memo, as requested by the County, which was a follow-up to the technical conference that took place in Washington, D.C. The memo stated that FEMA considered the data presented by the local entities, but will continue to use the same data as before (attached). Community meetings will be planned for public comment.

The County hired Robert McGaughey as its County Engineer. The search for a Public Works Director continues.

**Skagit River General Investigation (Skagit River GI):** Lorna Ellestad introduced two representatives from Senator Patty Murray's office: Uriel Ybarra, Regional Director, and Sheila Babb. Both were in attendance as a part of their tour of Skagit County. Ellestad provided them with a background packet containing information from the technical conference in Washington, D.C. Copies are available upon request. Ellestad went on to explain that NHC is completing its

10% design of the measures. A formal scoping meeting with the U.S. Army Corps of Engineers (USACE) will be scheduled for the first of the year (2011). Dan Johnson, USACE, added that he is focusing on keeping everyone on track; there are a lot of pieces to fit together.

#### **CFHMP First Draft – Review Guidelines**

County staff handed out the first draft of the *Skagit River CFHMP*. It was requested the group review the plan for items of importance that may have been left out, areas that should be developed further, or additional sources of information that should be referenced. The AC and TCs will meet to discuss the Plan in September.

## "Blueprint" Meeting Discussion

Boudinot opened the conversation by explaining there was a request for the FCZD, CFHMP, and Skagit River GI to be better organized. A subcommittee was formed, which included Todd Carlson, Bob Carey, Leonard Halverson, and Esco Bell. The group put a "blueprint" together for review.

Carlson explained the subcommittee was formed, because it seems cohesion is lacking between the CFHMP and the GI. The question about funding sources is pressing, and the recent absence of Swinomish Tribal representation is critical. It is agreed everyone wants to reduce flood hazard risks. However, because of the turn-over in county leadership, accomplishing this goal is unclear. The "blueprint" is an alternative way to pinpoint the actions required to finish the CFHMP and GI.

Carey added that while there has been increased coordination between entities and increased congressional support, there have also been budget cuts, and the loss of consultants and leadership. This leads to a fundamental disconnect of what the FCZD is trying to do. The subcommittee wants to figure out how to continue to build momentum while filling in the gaps.

Halverson suggested the Upper Skagit Tribe join the FCZD. Mayor Ed Brunz and Kunzler agreed another tribe should be contacted. Ultimately, though, Halverson expressed it is important to not lose sight of the primary purpose of flood risk reduction, which is to protect life and property.

Esco Bell described the CFHMP as a flexible funding tool, and that the FCZD does not need the analytical information required for the GI to begin a list of suggested projects, at this time. Daryl Hamburg agreed with this approach. Kunzler further expressed that immediate needs and long range plans should be put together by each technical committee.

Carlson continued the discussion by providing an overview of the "blueprint" flow chart. Specifically, the chart is designed to try to clarify the role of the FCZD committees. It illustrates the addition of a "flood director" who can lead the process of the CFHMP and GI. Kunzler pointed out Ellestad currently fulfills that role.

Jason Easton does not want to lose momentum, and feels the FCZD should set the GI aside in order to focus on the draft CFHMP. Ellestad further explained the CFHMP and GI have distinctly different processes and it is a good idea to keep the two separate.

Berentson stated county government is very similar to a professional football team: Skagit County voters are the season ticket holders, the Board of Skagit County Commissioners are the owners of the team, the Skagit County Administrator is the General Manager, and the Public

Works Director is the coach. He further explained that this analogy must make him and Ellestad the Offensive and Defensive Coordinators. All in all, the FCZD can give advice to the owners, but is unable to call the plays.

In closing, Boudinot stated the "blueprint" has given much to ponder. The FCZD may need to be better organized, and the subcommittee has started that conversation. This can be discussed further at future meetings.

## **Suggested Next Steps and Meeting:**

Technical Committees should read through the draft ordinance put out by FEMA regarding flood insurance rate maps.

The next AC meeting is scheduled for Monday, September 20, 2010, from 2:30 to 4:30 p.m. Technical Committee members have been requested to attend, as well. The FCZD is on hiatus until then.
