#### **Skagit River GI Update**

Dan Berentson reiterated the *Future Scoping Meeting Read-Ahead Report* has been submitted to the U.S. Army Corps of Engineers (USACE) Headquarters. The County is continuing to position the Skagit GI so that staff will be able to move forward with the study when more funding is available. In addition to this, staff will be coordinating the annual letters to request funding from Congressional delegates.

#### **Hydraulic Effectiveness Report Presentation**

Malcolm Leytham, NHC, gave a presentation regarding the hydraulic effectiveness of several flood management measures that could be constructed along the Skagit River at and downstream of Sedro-Woolley. Flows, water levels, and spills of each measure were analyzed for 50- and 100-year flood events. Performance data comes from a one-dimensional HEC-RAS hydraulic model from previous work generated by Pacific International Engineering and the USACE. The economic feasibility, environmental impacts, and extensive design of each measure will be shared in another phase.

Four key spill locations exist along the river: Sterling; Dike, Drainage, and Irrigation District 12; Division Street; and Fisher Slough.
